## **Kansas Nonresident Whitetail Deer Permit Instructions:**

Nonresident hunters must apply for a Kansas Nonresident Deer Permit through a special lottery draw. This year, applications will be accepted April 1-28, 2023.

**\*\*The credit card you provide with your application will be charged for the total price of the permits IF your application is successfully drawn\*\***

There have been mixed answers from KDWP as to whether a current year license has to be purchased prior to the draw.. but the most consistent answer has been YES even though it does not make people when they still have a 2022 license in effect. For people who do not have an active license, the system does make you purchase a 2023 hunt license. People within the 364 of their 2022 license, it allows you to complete the transaction without renewing the hunt license.

We have been told now after many calls for clarification by KDWP that if the 2022 hunt license expires between the application submittal and the tag draw.. which will 100% occur.. that the application will be rejected at draw. So, we are asking everyone to purchase the license. We would hate for that to be the reason of not drawing your tag. It has been explained as a glitch in the new system that will be fixed for 2024.

- Select first image – Purchase License, Permits & Tags
- Login at left of page
  - Existing Customers **Login** with either your SSN, KDWP or Driver's license
  - If you are a new customer, follow prompts to **Enroll Now**

Once you are logged in:

- Certify information is correct
- Click on image at top of page - Limited Draw Applications
- Preference Points – if you have preference points, they will automatically be applied to your application.
- Select- Nonresident whitetail either sex deer
- Click - Next
- Select- Apply as an Individual
- Click – Next
- Equipment Type: select weapon you will hunt with
  - Archery, Firearm or Muzzleloader

- Select your four hunt choices noting the primary unit, additional unit, and priority. Please select following priorities:
  - UNIT 12
    - Additional UNIT 14
    - Priority 1
  - UNIT 11/19
    - Additional UNIT 12
    - Priority 2
  - UNIT 13
    - Additional UNIT 12
    - Priority 3
  - UNIT 14/19
    - Additional UNIT 12
    - Priority 4
- -Click- NEXT
- Select fulfillment option for awarded tags
  - Select PRINT and verify shipping address
  - These will be mailed to you, and you must bring them with you for the hunt
- -Click- NEXT
- Enter credit card information to keep on file
  - **If your credit card is denied at the time of draw, you will not be successful in the draw so please be sure it is up to date**
- Select NEXT
- Verify information that has been submitted
- -Click- FINISH & CHECKOUT- at bottom right of page

**\*\*You MUST have an active license at the time of lottery draw or your application may be rejected\*\***

- To purchase your license:
  - Select – Home at top menu bar
  - Click on image at top of page – Buy Licenses, Permits & Tags
  - Enter “108 – Nonres Hunt License” in the search bar (\$95)
  - Click “Add to cart”
  - Certification Required:
    - If you do not have your Hunter’s Safety #, provide the State and check the box that says you attest to having taken the hunters safety course but cannot provide the number at this time
    - Click – Save Certificate
  - Shopping cart should contain:
    - 108 - Nonres Hunt License, 1 year, \$95.00
